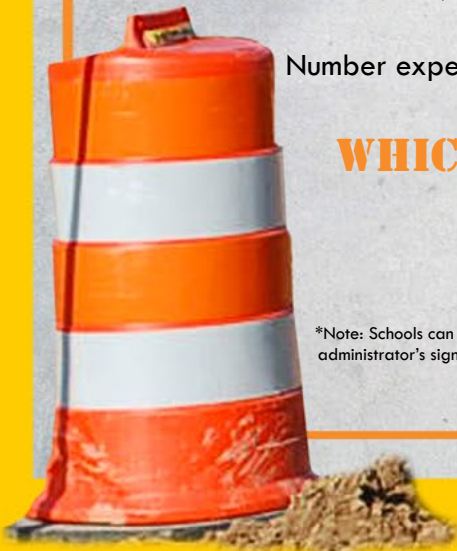

2013 MICHIGAN CONSTRUCTION CAREER DAYS PARTICIPATION RULES AND REQUIREMENTS

The rules and requirements outline herein shall be applicable to all Exhibitors, Schools, Facilities and any others (herein referred to as "participant") participating in the above event.

By my signature below, I hereby warrant that I am duly authorized to sign this document on behalf of the applicant exhibitor. Oh behalf of the applicant exhibitor, I also acknowledge that I have received a copy of the Participant Rules and Requirements, and agree to comply with all such requirements.

Authorized Signature

Commercial General and Umbrella Liability Insurance. Participant shall maintain commercial general liability (CGL) and, if necessary, commercial umbrella insurance with a limit of not less than \$1,000,000 each occurrence and shall cover liability arising from premises, operations, products-completed operations, personal and advertising injury, and liability assumed under an insured contract (including the tort liability of another assumed in a business contract). "Oakland Community College, its elected and appointed officials, employees, students, agents and volunteers" shall be included as an insured under the CGL and under the commercial umbrella, if any. This insurance shall apply as primary insurance with respect to any other insurance or self-insurance programs afforded to OCC. Participant waives all rights against Oakland Community College, its elected and appointed officials, employees, students, agents and volunteers for recovery of damages to the extent these damages are covered by the commercial general liability or commercial umbrella liability insurance maintained pursuant to this paragraph. Insurer shall endorse CGL policy as required to waive subrogation against OCC with respect to any loss paid under the policy.

Automobile and Umbrella Liability Insurance. Participant shall maintain automobile liability and, if necessary, commercial umbrella liability insurance with a limit of not less than \$1,000,000 each accident. Such insurance shall cover liability arising out of any auto (including owned, hired, and non-owned autos).

Commercial Property Insurance. Participant may, at its option, purchase insurance to cover its personal property, including, but not limited to, its machinery, tools and equipment. In no event shall OCC be liable for any damage to or loss of any such personal property sustained by Participant, whether or not it is insured, even if such loss is caused by the negligence of Oakland Community College, its elected and appointed officials, employees, students, agents and volunteers.

Workers Compensation Insurance. Participant shall maintain workers compensation and employers liability insurance as required by law.

Evidence of Insurance. At least 30 days prior to the event, Participant shall furnish OCC with a certificate(s) of insurance, executed by a duly authorized representative of each insurer, showing compliance with the insurance requirements set forth above. Any waiver of Participant's obligation to furnish such certificate or maintain such insurance must be in writing and signed by an authorized representative of OCC. Failure of OCC to demand such certificate or other evidence of full compliance with these insurance requirements or failure of OCC to identify a deficiency from evidence that is provided shall not be construed as a waiver of Participant's obligation to maintain such insurance, or as a waiver as to the enforcement of any of these provisions at a later date.

No Representation of Coverage Adequacy. By requiring insurance herein, OCC does not represent that coverage and limits will necessarily be adequate to protect Participant and such coverage and limits shall not be deemed as a limitation on Participant's liability under the indemnities granted to OCC.
